

Statement on the Kabul Airport Attack



The New York Young Republican Club grieves the loss of thirteen servicemembers at Hamid Karzai International Airport in Kabul, Afghanistan on August 26, 2021.

This latest loss underscores the unmitigated failure of the Biden Administration's disengagement from Afghanistan. Members of the Administration from the Cabinet-level down have shown themselves to be inept, unaccountable, and distracted. Their poor prioritization has left their hands indelibly stained with the blood of the very young Americans that members of this Administration consistently disparage.

With so much effort focused on pandering efforts like integrating sexual deviants into the armed forces and educating members of the military on "white rage," one cannot help but wonder if leadership (e.g., Chairman of the Joint Chiefs of Staff Mark Milley) might have been distracted from doing their actual job of terminating conflicts victoriously. Of course, given that Milley was never a boots-on-theground soldier, perhaps one should not be surprised that he lacks the skill set to execute well. (Milley's alleged experience in Panama has been grossly exaggerated.)

The genius running the CIA, William Burns, deserves total condemnation. His idea of facilitating Americans' departure from

Afghanistan included meeting with the Taliban and giving them a list of Americans and our Afghan supporters. Even if we accept that his counterpart was acting in good faith (a tenuous assumption at best), this list could nonetheless be leveraged by others within the Taliban with devastating impact.

Secretary of State Antony Blinken has shown himself to have far less management capability than the median McDonald's area manager. State Department clipboard Karens have been turning away already-vetted Afghans who have made it through the carnage outside the airport for unspecified reasons.

And at the top of the heap, Vice President Kamala Harris has been on a leisurely trip to, of all places, Vietnam, while her boss, President Joe Biden, eats ice cream at Camp David and in Delaware. These clownish buffoons have no credibility on the world stage, and their inability to effectuate this evacuation vacates any shred of legitimacy that they might hope to command in future international negotiations.

The New York Young Republican Club expresses its condolences to the families of those who lost their lives in Kabul, and we call for the politicians and military leaders to resign and be impeached or court-martialed so that the American people can have a full and transparent accounting of their crimes.


Afghanistan Chaos: A National Disgrace

Where was President Joe Biden when Afghanistan fell? As the once free Afghan people fled in terror from the Taliban surge that has recaptured their homelands with lightning speed, the American Commander-in-Chief did what he so often does in times of crisis, hide. With Bagram and Kandahar in the hands of militant terrorists, and the enemy at the gates

of Kabul heading into this past weekend, Mr. Biden was undeterred in achieving his primary mission: going on vacation. Despite the increasing speed and violence of the Taliban takeover, Biden's Department of Defense shill, John Kirby, wilted under questioning from a persistent media on Friday in place of his boss, refusing to acknowledge any mistakes in the

Biden administration's handling of the troop withdrawal, and reiterating yet again that the military capabilities of the Afghan army were more than enough to prevent a total loss of control to Taliban forces.

Echoing the talking points of just a few weeks ago from the likes of Joint Chiefs of Staff Chairman Gen. Mark Milley, and the President himself, Biden surrogates spent the weekend insisting that such a rapid deterioration was not what the intelligence on the ground suggested. This was a lie. Without American air support, or clear and actionable consequences for Taliban aggression, the Afghan military was left without the backing or guidance of its most powerful international ally, and the chaos unfolding now is a direct result of that egregious error. For months, the United States Congress has been receiving updated intelligence briefings on the tenuous hold President Ashraf Ghani had over Afghanistan, and the extreme likelihood of a Taliban resurgence if American military and private contractor forces were to exit the country too quickly. Biden's team was privy to this exact same information and yet inexplicably chose to implement their accelerated withdrawal anyway, triggering a humanitarian catastrophe



that has already forced women and children back under Islamic extremist subjugation while those who dare resist are literally being butchered in the streets.

So the question must be asked again, where was President Joe Biden? Was he seeking more counsel from his Secretary of Defense Lloyd Austin? The same man who oversaw the abysmal failure of the Iraq troop withdrawal in 2011. Was he brainstorming how to spin the polling on this foreign relations nightmare with his Press Secretary Jen Psaki? The same woman who couldn't tell Iran from Iraq during her time with the Obama State Department and who is now also conveniently on vacation at a time where strong and unambiguous messaging from the White House matters most. It is now clear that while Biden was enjoying yet another leisurely respite at Camp David over the weekend, the world watched in horror as Afghanistan burned after the current American President abandoned yet another ally.

The New York Young Republican Club calls for the immediate resignation of senior ranking military leader Mark Milley for failing to adequately evaluate and transparently convey the intelligence community's Afghanistan risk assessment. No American, in good conscience, can witness this level of failure without demanding accountability. Furthermore, the New York Young Republican Club denounces Biden's remarks blaming the crisis in Afghanistan on everyone but himself. While we believe that the United States' mission abroad should not be focused on nation building, we condemn the Biden administration for its reckless execution of U.S. troop withdrawal and utterly inexcusable betrayal of our Afghan allies. We also demand that the Biden administration rescue thousands of U.S. citizens that are currently still trapped in and around Kabul.

Statement Against De Blasio's Mandatory Vaccine Pass

As stated on December 21, 2020, the New York Young Republican Club is committed to positive action that supports the health of every American citizen. However, we once again reaffirm our opposition to mandatory vaccination at any level of government.

Our party follows science. In December, we concluded, as did most of the country, that vaccines would defeat COVID-19. Democrat leadership and strategists, had, at the time, cast doubt about the safety and viability of the vaccines since they were first made available through Operation Warp Speed. In recent weeks and today, Democrats have continued to destroy the people's faith in public health institutions

by supporting misleading media narratives about vaccines' effectiveness and safety. When a political party conspires with media and big tech to shut down speech, it should come as no surprise that the average New Yorker has no confidence that a vaccine will transmission o f the novel coronavirus, particularly in the face of a new variant. Because the media and the Democrat-controlled, supposedly apolitical public health institutions have engendered such distrust, New Yorkers remain unable to resolve the open questions around causal relationships between serious conditions (e.g., Bell's Palsy, fertility) and receipt of these as yet unapproved vaccines, just just as they were eight months ago.

Despite public concerns over the inoculations, Mayor Bill de Blasio has chosen to punish, rather than listen to, New Yorkers who are justifiably skeptical. The ironically named "Key to NYC Pass" locks the city down to anyone who questions de Blasio's judgment about his or her own personal health decisions. In his address explaining the vaccine mandate, he declared that anyone who declines to subject themselves to his preferred medical intervention prevented from "living a good, and full, and healthy life." While he attempted to blame the virus for this choice, he made it clear that his government action would impose this harm, which the virus itself could not. Such a sentiment baffles anyone familiar with the Democrats' decades-old mantra of "my body, my choice".

In recent weeks, vaccination rates have started to rise, perhaps due in part to the numerous recreational and financial incentives extended to recipients across the country. This has brought our national vaccination level beyond what public health officials previously claimed would give us herd immunity. Apparently unsatisfied with the results of offering up so many "carrots", some of our elected leaders seem giddy to switch to the "stick" and impose pandemic restrictions historically imposed only in times of clear and imminent crisis with a rational basis to a legitimate government objective. COVID-19, even the delta variant, has been found to have a mortality rate as low as one percent, according to the Director of the National Institute of Allergy and Infectious Diseases and media darling Dr. Anthony Fauci. Because of the vaccines' decreasing and uncertain effectiveness in preventing transmission of particular strains, efforts at inoculation should be focused on encouraging those most at risk to get vaccinated in order to protect their own health, while respecting their own bodily autonomy. Such a measure would at least bear a rational relationship to the legitimate government objective of saving lives.

Instead of making it a priority to protect the most vulnerable of New Yorkers, however, Mayor Bill de Blasio has chosen to attack the civil liberties of an entire third of the city who question the wisdom of, and avoid, a vaccination mandate for even healthy young adults. Such suspicions stem from a lack of trust in an inept city government that has dismissed legitimate medical concerns while simultaneously ignoring the pressing local quality of life issues, such as rising crime, that communities face on a daily basis. Rather than diligently protecting the one to two percent of the city's population at greatest risk, Mayor de Blasio chooses to preoccupy himself with making sure that those who disobey his edict are not permitted to "[live] a good, and full, and healthy life."

The COVID-19 pandemic and draconian government restrictions imposed in its name have killed tens of thousands and destroyed livelihoods across our beloved New York City. Many still grieve the loss of their parents, grandparents, friends, businesses, and even children. The New York Young Republican Club supports scientifically rooted and properly restrained measures to make our city a better place. Our club does not, however, support irrational measures that punish the population for exercising a right to bodily autonomy.

Event Spotlight: August Speaker Series with Scott Presler

Club History:


1948 - The Club helped elect another Club member, George Frankenthaler, as the Surrogate of New York County, the first and last Republican ever elected to that office. The Club ran one of its members, John Ellis, against former Club member Democratic Congressman Vito A. Marcantonio; like Frederick P. Bryan 2 years earlier, John Ellis' campaign failed to secure a win. Thomas E. Dewey was the Republican candidate again in the 1948 presidential election, with California Governor Earl Warren on the bottom half of the ticket. was almost unanimously projected to win against incumbent Harry S. Truman, who had taken over from Roosevelt when he

died in office in 1945. Dewey received 45.1% of the popular vote to Truman's 49.6%. In the Electoral College, Dewey won 16 states with 189 electoral votes, Truman 28 states with 303 electoral votes, and Thurmond four states (all in the South) with 39 electoral votes. The key states in the election were Illinois, California, and Ohio, which together had a combined 78 electoral votes. Truman won each of these three states by less than one percentage point; had Dewey won all three states, he would have won the election in the Electoral College, and if he had any two, this would have forced a contingent election in the House of Representatives.

I.R.O.A.R. v. de Blasio

The legal battle against New York City's vaccine mandate has begun on Staten Island.

In an action brought against Bill de Blasio and the City of New York, the Independent Restaurant Owners Association Rescue ("I.R.O.A.R.") seeks a permanent injunction against NYC Executive Order 225 to prevent damage to small businesses that have already been suffering under the City's rules.

The Petition filed by I.R.O.A.R. on August 17th alleges that the vaccine mandates are "arbitrary, irrational, unscientific, and unlawful," and are continuing the pattern of City, State, and Federal mandates that have "severely and irreparably damaged small businesses all over the [c]ity."

Attorneys Mark Fonte and Louis Gelormino form a strong Constitutional basis for their arguments, the first appearance for which is scheduled for September 3rd.

The first cause of action argues that the Executive Order is arbitrary and capricious. The mandate applies to indoor dining, indoor fitness facilities, and indoor entertainment facilities. However, December 2020 data released by the (former!) Governor Cuomo himself stated that only 1.4% of the

state's Covid-19 infections can be sourced to these locations. By contrast, almost 75% of the spread can be attributed to gatherings in people's homes.

number fact-specific There are a of arguments set forth further demonstrating the arbitrariness of the Executive Order. particularly remarkable However, one argument is relative to the popularized vaccination rate - which is included in the Executive Order - that 56% of New York City residents are fully vaccinated. That statistic, they argue, is entirely misleading. The April 1, 2020 census estimated the population of New York City to be about 8.8 million - however, 20% of the population is under the age of 18 and about 10%-15% is under the age of 12. Therefore, 10%-15% of the population is **not** even able to receive the vaccine. That means the vaccinated percentage of people eligible to receive the vaccine is much higher, at anywhere between 70% and 77%.

The Petition rightfully lies heavily on *Roman Catholic Diocese of Brooklyn v. Cuomo*, the Supreme Court case decided last year which upheld the notion that the Constitution does not go away, even in an emergency. As Justice Gorsuch stated, "[e]ven if the Constitution has taken a holiday during the pandemic, it cannot become a sabbatical." The mandates must be narrowly tailored in order to satisfy the strict scrutiny required of them – and, instead, the Mayor's orders became more voluminous, in contravention of the increased medical and scientific data that has become available.

Massachusetts v. Jacobson, a Supreme Court case from 1905 which upheld mandatory vaccine laws, has been a part of the promandate argument since around the start of the pandemic itself. The Petition gets ahead of this argument by distinguishing these mandates with those at issue in Jacobson.

Even then, the Court held that states have "authority... to enact quarantine laws and 'health laws of every description'" unless such laws bear "no real or substantial relation" to "public health." However, a number of lower Courts have rejected Jacobson, and Roman Catholic Diocese makes it clear that Jacobson does not govern. In fact, not one Justice in Roman Catholic Diocese – even those who dissented – argued that Jacobson provided the operative framework for Covid-19 regulations.

The first cause of action concludes with the argument that the fundamental right to "pursue a calling" is "impinged on and significantly interfered with" by the Executive Order. Beyond patronizing any of these institutions, the Order makes it impossible for those who choose – or are unable – to be vaccinated to work in any of the industries affected by the mandate.

The second cause of action argues that the mandate is inherently problematic as it makes no exceptions and grants no accommodations for individuals who cannot or should not be vaccinated. The factual bases for this argument run the gamut for reasons scientific and spiritual.

For people who have had Covid-19 and recovered, the vaccine is not necessary. The Petition cites to a study found on the CDC website itself, which states that the "rates

according positivity antibody commercial kits was still high at 8 months after infection." Moreover, there are serious medical concerns for people who may have an adverse reaction - in fact, the CDC states (emphases from the Petition) that "[p]eople with HIV and those with weakened immune systems due to other illnesses or medication might be at increased risk for severe Covid-19. They may receive a Covid-19 vaccine. However, they should be aware of limited safety data." Other conditions with limited data include "other autoimmune conditions, Guillain-Barre syndrome, Bell's Palsy, and anyone who is allergic to one or more ingredients of the vaccine." There is simply not enough research, the argument goes, to justify such a mandate for these people who may be put at risk by receiving the vaccine.

Additionally, certain religious beliefs do not condone injecting a "relatively unknown foreign substance into one's body." The mandate thereby violates the freedom of religion and compels employers to violate Title VII of the Civil Rights Act of 1964.

The arguments set forth are clear and strong. We hope justice prevails and that the Court recognizes the unconstitutionality of this executive order and any executive order that continues to destroy small businesses and the livelihoods of their owners and employees.
