Statement on Columbus Day



Today, the New York Young Republican Club honors Christopher Columbus, a monumental figure in world history and a symbol of Italian-Americans' foundational role in American society.

Christopher Columbus embodies values that are disappearing too fast from American society: a keen interest in the unknown, willingness to take risks, and determination to succeed where others have failed in the past. Columbus may not have originated the idea that the world was round, but he was the first one who took action to enable permanent settlement of the Americas. In doing so, he catalyzed the emergence of a new set of Great Powers and the expansion of the civilized world.

Today, the good name of Columbus is at risk; ongoing attempts to malign his reputation abound in the leftist media and in Democrat political circles. These critics insist on cherry-picking from his voluminous accounts of meeting with Indians to find behavior that they deem objectionable. They take his actions out of their historical context, and they contrive motives with no basis in fact. This must end.

In partnership with Lega Giovani, the New York Young Republican Club will continue the fight to restore and defend the reputation of Christopher Columbus. We will not abide by the denigration of Italian-American culture, and we will not permit the evisceration of Italian-Americans' symbols by the woke mob.

NYYRC Position on NY's Constitutional Amendments Ballot Proposal

New York City is not just choosing a new mayor in November. All New York voters will decide the fate of five proposed constitutional amendments on the General Election Ballot on November 2. New York is 1 of 24 states where only legislators can initiate a ballot proposal. Before getting on the ballot, proposals must be approved by both houses of the legislature, then voted on again in both chambers after the Assembly and Senate have gone through one election cycle. New York voters will have their final say on the ballot

measures in November and, if approved, they will go into effect on January 1, 2022. These proposed amendments are great in scope, dealing with elections, redistricting, the environment, and the courts. Of particular concern are three of the proposed amendments that seek to enshrine Democrats' political advantage in the state of New York.

1.Amending the Apportionment and Redistricting Process – **OPPOSE**

New Yorkers will decide whether to amend the apportionment and redistricting process in November. States must redraw the boundaries of legislative and congressional districts to reflect population changes every decade following the U.S. Census. In New York State, the proposed amendment would count incarcerated individuals in their last place of residence instead of where they are incarcerated, and it would require the state to count all residents in districts even if they are not U.S. citizens. The proposed amendment would also change the approval process of legislative district lines for New York's House of Representatives, State Senate, and State Assembly. In 2014, a state constitutional amendment created a 10-member, so-called Independent Redistricting Commission to redraw district lines which would require the approval of the Legislature after a series of public hearings alongside the approval from seven members of the commission, including appointees from each majority and minority legislative leader. The proposed amendment would still require the approval of at least 7 members of the Commission, but it would get rid of the requirement that they are supported by appointees of each legislative leader. In short, this proposed amendment would make it easier to bypass the minority party in drawing new district lines.

The New York Young Republican Club adamantly opposes what can only be called a redistricting power grab by New York state Democrats. Selfinterested politicians should not decide the conditions under which they are elected. Furthermore, the 2020 proposed constitutional amendments would make it even more difficult for Republicans to retain much control. In the past, Republicans have increased their number of seats in the New York State Senate by appropriately counting New Yorkers from downstate imprisoned in GOP-dominated rural areas. While inmates of the New Department of Corrections may declare their official residence in other counties or even other states, their physical presence within upstate prisons is, and should remain, the determining factor for government resources redistricting. Other changes would undo two provisions of the original 2014 amendment that were designed to protect the interests of minority parties in both houses. Democrats now hold a supermajority in both the Senate and Assembly and will inevitably be able to control the outcome of redistricting under the new provisions.

2. Right to Clean Air and Water - OPPOSE

New Yorkers will be asked to consider amending the New York State Constitution's Bill of Rights to include a guarantee to "clean air and water" in November. The amendment explicitly calls for the "right to clean air and water, and a healthful environment." Including such an ambiguous amendment will undoubtedly create confusion and its implications will be subject to interpretation in the courts. New York has the country's highest annual per-household lawsuit costs, and if the Green Amendment is approved, it will only make matters worse by creating an explosion of litigation that would have little impact on the environment. Additionally, costs environmental compliance are already unnecessarily high. Passing this proposal would broaden state and regulators' city responsibilities and operational framework, leading to even higher costs which ultimately would lead to a mass exodus of businesses from New York State. New York's regulatory system is already both inefficient and ineffective. In 2019, New York City Council passed Local Law 97, an ordinance designed to reduce the city's carbon emissions. This ordinance, however, has had little impact on the environment while imposing heavy costs on landlords and developers, thus driving up housing costs. Perhaps even more importantly, this vague grant of a "right" to environmental regulators, rather than common citizens, will certainly open a door to rampant abuse of power. New Yorkers can expect soon to see their individual sovereignty and privacy evaporate as politicians completely removed from their everyday lives micromanage citizens to "protect" their "healthful environment."

3. Same-Day Voter Registration: OPPOSE

As part of the Democrats' current crusade to supposed "voting promote rights", overwhelmingly blue state legislature is seeking to amend the constitution of New York by removing a requirement for voters to be registered at least 10 days before an election. Without such a restriction, lawmakers would be free to implement a same-day registration process statewide, further complicating an already suspect election system. Far from achieving any semblance of improved access to the ballot box, a same-day registration option would only result in additional confusion and chaos for strained poll workers, redirecting Election Day resources away from existing registered voters, and increasing wait times for

everyone. While the New York Young Republican Club firmly believes that eligible citizens should exercise their right to participate in our representative government at every opportunity, we also believe in personal accountability and the consequences of actions. Informed and responsible residents of the state of New York have ample opportunity to register to vote in a number of different ways well ahead of the existing 10-day cut-off. This brief and bearable buffer not only protects the validity of voter registrations, but also helps polling places to prepare for potential turnout, and prevents the possibility of literal last-minute "new" voters swaying results after early projections are publicized. Furthermore, the current deadline allows for the necessary time to verify addresses and voting districts, ensuring that only those citizens directly governed by elected officials are casting ballots in the appropriate races. The New York Young Republican Club urges all New Yorkers to vote NO on Proposal 3 to preserve the integrity of elections within the Empire State.

4. No-Excuse Absentee Voting - OPPOSE

New York state's Constitution currently allows voters requesting an absentee ballot to provide an excuse for their inability to vote at their designated polling place. First and foremost, proponents of no-excuse absentee voting claim that the measure would increase voter turnout, which has proven not to be the case in a meaningful way. More importantly, voter fraud rarely occurs at the polls, instead of occurring through absentee ballots. The vast majority of voter fraud prosecutions involve absentee ballots that were illegally cast. For this reason, most other developed nations restrict or totally prohibit in-country postal voting, meaning that New York's permissions already constitute an anomaly. Under a no-excuse system, there is no way to guarantee the applicant is voting at the ballot. Eliminating the last safeguard for absentee voting, namely providing an excuse, is bound to exacerbate the issue of voting fraud. In early July, the New York City Board of Elections acknowledged a discrepancy in the calculation of ranked-choice votes, showing that over 100,000 test votes were added to the count. New Yorkers have long endured the incompetence of the city's Board of Elections. We can only imagine how many more election-related issues will arise if New York decides to implement no-excuse absentee voting when the current system for processing absentee ballots can barely handle the increase in volume under a no-excuse system. The no-excuse absentee voting option would strain the outdated, inefficient, and manual process for mailing, accounting for, and counting absentee ballots. In 2020, New York waived absentee voting requirements because of the pandemic resulting in local boards of elections having to deal with record numbers of which absentee ballots led extraordinary delays in deciding election outcomes. Delaying election outcomes will add to public suspicions about the validity of elections.

5. Expanding the New York City Civil Court Jurisdiction - SUPPORT

This proposal would impact the bloated dockets of the New York Supreme Court by expanding the jurisdiction of New York City's civil court. The New York Young Republican Club not oppose this amendment, as this is not the first time New York City's civil court has been expanded. However, we are disappointed with New York's imposition of draconian coronavirus restrictions during much of the pandemic. These restrictions have led to a backlog of cases in New York courts and many state district attorneys say they do not expect to be caught up with cases for years. Coronavirus restrictions have slowed civil and President Biden's settlements eviction moratorium has led a large number of landlords to find a way around the housing court backlog by pursuing non-paying tenants in civil court. We hope that expanding New York City's civil court's jurisdiction will reduce the existing court backlogs and that the court system will resolve these pressing cases in a timely manner.

Condemnation of House GOP Traitors

The New York Young Republican Club condemns in the most unreserved terms the radical action by nine self-proclaimed Republicans in the House of Representatives to join in the Democrats' politically motivated screed against

Stephen K. Bannon, whom they have accused of acting in contempt of Congress.

These self-aggrandizing figures include notable losers like:

- Liz Cheney, who is roundly despised by practically everyone in Wyoming,
- Adam Kinzinger, whose most notable contribution to the American political landscape prior to jumping on the America Last bandwagon was ranked fifth on The Hill's 2011 "50 Most Beautiful People" list,
- Nancy Mace, an outright fraud who backstabbed President Donald J. Trump, and
- New York's very own John Katko. Katko is a typical RINO who will make pandering statements on critical issues like border security while selling Americans out.

The remaining five (Brian Fitzpatrick, Anthony Gonzalez, Jaime Herrera Beutler, Peter Meijer, and Fred Upton) are unremarkable and ineffectual members of Congress riding the coattails of anti-Trump fervor to get more favorable media hits than they could earn on their own merits.

Mr. Bannon, the 2019 recipient of the New York Young Republican Club's Frederic René Coudert Jr. Award, has a well-known and deep passion for the American people. He connects with members of the America First movement at a personal level, and they know that they can trust him for honest and forthright assessments of political affairs. That is what makes him dangerous to creeps in Congress who hate the very principle of America First because it damages their personal globalist interests.

These nine Republicans who voted to sic the Justice Department, led by a corrupt whacko, on Mr. Bannon deserve to be challenged in primary elections, and the New York Young Republican Club will support America First candidates who oppose them in 2022. We look forward to meeting with Katko's constituents, in particular, and we vow to make sure that they understand what a snake they have representing them.

Crypto-Marxists have no place in the Republican Party, and we will continue and expand our forceful advocacy to eradicate their toxic influence. These nine are a good start.

Senator Joseph R. McCarthy once said that "[o]ur job as Americans and as Republicans is to dislodge the traitors from every place where they've been sent to do their traitorous work." The New York Young Republican Club intends to carry this torch forward; we will drive RINOs to extinction.

Opposition To The Removal Of The Thomas Jefferson Statue

Several New York City Council members have long complained that the Thomas Jefferson statue emblazoned in their City Hall served as a reminder of the injustices perpetrated against communities of color throughout our nation's history. As a result, Mayor Bill de Blasio, a champion of the far left and their authoritarian cancel culture tendencies, has sought the removal of the statue of Thomas Jefferson from the New York City Hall. On October 18, officials on the Public Design Commission obliged by unanimously voting for the statue's removal. The Statue of Thomas Jefferson which has stood in the New York City Hall for more than 100 years is now bound to be removed by this year's end.

One of our nation's gravest sins was slavery. Thomas Jefferson, an imperfect man just like the rest of us, owned more than 600 human beings. He profited from the institution of slavery while understanding its inhumane and unconscionable nature. At the same time, few people in history



have done more than Thomas Jefferson to advance the cause of freedom. The freedom to speak freely is the essence of our democracy and the removal of Thomas Jefferson's statue is just one of many examples of the far left's distrust of the American people being capable of handling complicated issues.

The New York Young Republican Club passionately believes that a working democracy demands enlightened citizens and citizens cannot be enlightened if our history is erased and the freedom of speech is stripped away. We express the utmost disappointment toward the New York City Council's openness to cancel our history through its decision to remove the Thomas Jefferson statue from its halls. Early in its history, a predecessor organization to the

New York Young Republican Club was the first to inscribe Abraham Lincoln's name on its banner and to establish the first company of "Wide-Awakes," a group organized in support of Lincoln's 1860 campaign, in New York State. Speaking before an audience of about 1,500 at Cooper Union in 1860 at a speech that this group organized, Lincoln rightfully argued that the founding fathers, whom the left are desperately trying to cancel today, created a foundation that set the country on an anti-slavery course. This morally righteous course eventually allowed people of all colors and creeds to enjoy equal treatment under the law in the United States far before many other countries dignified their citizens with the same basic rights.

One of the most crucial questions of our day is where will this cancel culture hysteria stop? Today it's Jefferson, but who will it be tomorrow? Cancel culture annihilates reason by bypassing the processes by which social reasoning takes place. Our nation has come a very long way since the terrible evils of slavery through reason and humanity. Every day it increasingly seems that this battle between upholders of civilizational values and the perpetrators of cancel culture will not end well. In the end, it will be up to those who care for liberty and American civilization to exercise our fundamental values and virtues in order to ensure that our progress will endure the test of time.

NYC's Gifted and Talented Program - UNCANCELLED!

While most elementary students enjoy their hot and muggy NYC summers playing in the park or swimming at the beach, a few students stay at home or the local library taking practice tests in preparation for the Gifted and Talented entrance exam.

The Gifted and Talented (G&T) program identifies and supports exceptional students in kindergarten through 5th grade. Students entering kindergarten through third grade need to take a test that assesses their verbal and nonverbal skills. For students entering the 4th or 5th grade, their New York State test scores determine acceptance. Given the program is designed to challenge students to learn at an accelerated pace commensurate with their cognitive potential, teachers require additional training. If the student is accepted, the program prepares them for the opportunity to attend specialized middle and high schools.

My son is in his fourth year of G&T, and we are grateful for the opportunity he has. Together, the teachers, the principal of the school, and fellow G&T parents provide a support system for our children to thrive in an accelerated learning environment. But, as a parent, it is a struggle. When I come home from work, my son's homework, prep and studying are the top priorities, including on weekends. Unfortunately, during the COVID lockdowns, learning became virtual, and the G&T standard of education

dropped significantly. We saw protests escalating into riots during the shutdown, businesses were getting looted, and street skirmishes with the police; we realized the only thing keeping us in NYC was the G&T program, which demonstrates how vital this program means for many families.

On October 8th, NYC Mayor Bill de Blasio announced the phase-out of the Gifted and Talented program for elementary school students. This announcement was surprising, given that de Blasio assumed office in 2014, and just three months before the end of his term, he decided to terminate the program. Instead, he wants to replace it with another program, which to date, is unproven.

So why does the mayor want to terminate the program? He points out that ~70% of G&T students are White or Asian, but make up just ~30% of the classroom. At the same time, Black and Hispanic children fill ~65% of the school, but just ~25% of the G&T seats. He concludes there isn't enough diversity, which is driving his decision to phase out G&T for elementary school students by 2022.

I think it's a disservice to all residents of NYC to categorize students whose parents may originate across 195 countries into four buckets of race. The thought process is too simplistic, and I believe it is the primary driver of why policies driven by race fail to deliver. If your worldview race-driven, then predominantly automated response by New York City's Progressive Democrats is to call discrimination or outright racism. They believe, like de Blasio, the demographics in G&T, just programs, special representative of the community Therefore, the typical response is to eliminate merit-based programs and replace them with solutions deemed "more equitable." That new "solution" is called Brilliant NYC.

If Brilliant NYC raises the education standards for all students, then great. However, we should

test the new program for effectiveness before phasing out G&T. I'd like to see the results, because I don't know the details of the Brilliant NYC program. Will the program stress achieving academic excellence and critical thinking? Or will the program include indoctrinating our children with poisonous Leftist ideologies such as "the pillars of Western Civilization are evil?" Or will it have an anti-America agenda, while teaching Critical Race Theory? There are too many unknowns for de Blasio just to cancel the G&T program.

Instead of de Blasio canceling the G&T program. why not put a committee together to conduct market research. Using a simple questionnaire, the committee can discover what motivates parents to enroll their children in the program and what stops them. They can learn what works and what doesn't. They can ask questions such as, "How did you hear about the G&T program? What drove your decision to enroll or not enroll your child in the program? What actions did you take to prepare for the test? What tools did you use? How did you manage your time?" Then, if parents are short on resources, whether it's time or money, the administration can develop strategic solutions to address these programs. This research can create better education programs for our children.

As a parent of Hispanic descent, my wife and I talk to parents about school all the time. We talk about the G&T program, encouraging them to take the test and enroll their children. Based on our personal experience, I expect the research to show that many Black and Hispanic parents are unaware that the program exists. Although the details are available program's on the government website, a certain degree of ignorance prevents parents from informing themselves of it. Even if they are aware, they sometimes rationalize why their child may not qualify for the program. Conversely, when I talk to parents of Chinese, Taiwanese, Indian, or any other Asian descent, they are aware of G&T, and they usually learn about it through word of mouth from other parents. They also have the testing deadlines, and their children are preparing for the exam.

Therefore, the mayor and his administration need to promote the program better, describe the testing requirements, and share the deadlines with all parents. And suppose the mayor wants to improve the enrollment and acceptance statistics for Black and Hispanic students, then they need to promote G&T more to these demographics.

While working on the demand side of the equation, the administration needs to improve the supply. They need to train more educators to teach and deliver G&T. The more teachers they can prepare for G&T, the more classes and seats can be made available to accommodate the increase in demand. Working both the demand and supply sides of this equation requires a commitment to expand the G&T program, not end it. The result is there will be an increased demand for specialized middle and high schools in NYC. For example, there are eight technical high schools in NYC that require students to take the Specialized High School Admissions Test (SHSAT) to apply. Why not set a goal of doubling the amount in 10 years?

I acknowledge the process for a student to attend a top-tiered university is competitive. Students need to demonstrate, at a minimum, a history of consistently delivering academic excellence. Getting into these schools helps when the student attends a specialized high school. The G&T program is the vehicle that provides working or low-income families the opportunity to prepare and attend these schools, provided the student, with the help of the parent(s), is willing to put in the work.

My family and I are waiting for the following election results to determine whether we will stay in this great city or go. The parent's values are at the very foundation of a child's education and long-term success. This means, regardless of whether it's the G&T program or the Brilliant NYC program, if the family's values include their child achieving academic excellence, the parents will do whatever it takes to find the right vehicle to get them there.

In the end, enrollment and acceptance into the G&T program have less to do with a child's skin color or ethnic background and more to do with the parents taking ownership of their child's education and academic performance. They are fully committed to seeking and providing the best education opportunities they can afford. Rather than being passive and waiting on the school officials or the administrations to tell them about the program, parents need to do their research, talk to other parents, and take action!

Jackie Robinson's Home Run Trot of Character Around All Bases

Jackie Robinson has become immortalized in American history for being the first African American baseball player in Major League Baseball (MLB) and has subsequently had his #42 jersey number retired by all teams in MLB. He was an accomplished player on the Diamond, playing for the Brooklyn Dodgers having been selected for 6 All-Star games and having won a World Series with them in 1955. He is a member of the baseball Hall of Fame and was elected on the first ballot in 1962. While this aspect of his legacy is well known, seldom does the discourse on his accomplishments touch on other elements of his great legacy and contributions to our nation and local community. Sports are a great bridge builder, however when looking at the legacy of Jackie Robinson his influence and work extended beyond the Diamond.

Jackie Robinson would embrace being a trailblazer at a young age. Prior to his notoriety in baseball, he attended UCLA where he became the first African-American athlete to win varsity letters in four sports: baseball, basketball, football, and track. This was an early preview of his high character and commitment to excellence despite adversity. In 1942, he was drafted for service in WWII and eventually entered officer candidate school. He received a commission as a second lieutenant. At the time, there was not a high concentration of African-Americans in officer candidate school, thus it was quite an accomplishment for Jackie Robinson. In training and enlistment, he still faced racial prejudice, however, and was not afraid to be outspoken about it. For this he confronted local command and helped facilitate reform.

Jackie Robinson was also recognized as a humble humanitarian. In 1964, the New York Young Republican Club honored him with the War Memorial Award (now known as the Philip J. McCook Award) for his contributions to the community and exemplifying and promoting the spirit of liberty and individual responsibility in society. Other iconic names and past recipients of this prestigious award from the NYYRC included President Herbert Hoover, New York Governor and Vice-President candidate Thomas Dewey, President Dwight D. Eisenhower, President Richard Nixon and Vice-President

Nelson Rockefeller.

Other examples of Jackie Robinson's work outside the Diamond included early activism with the NAACP and the Civil Rights movement, while developing relationships with influential leaders including President John F. Kennedy and President Richard Nixon to encourage them to embrace this platform. He was also a strong supporter of Vice-President and notable alumni Nelson Rockefeller during his run for President and had worked on his campaign. He also became successful in business, serving as Vice-President of Personnel at renowned coffee company, Chock Full o'Nuts.

In 1964, Robinson co-founded the Freedom National Bank-an African-American owned and operated bank in Harlem, New York-with businessman Dunbar McLaurin. Robinson was the commercial bank's first Chairman of the Board. He believed in providing opportunities for minority communities and encouraged economic development in those areas. He was a proponent of investing in the individual and recognizing the natural rights we all enjoy as citizens of the United States to advance and grow. He was willing to draw attention to the plight of urban communities that had families that were struggling to be economically viable. By helping establish the Freedom National Bank, these communities had a visible sign of investment in them and it spurred the growth of small businesses. The American Dream was presented in a robust way with Jackie Robinson's humanitarian efforts. These communities were able to embrace advancement and economic opportunity to support themselves and their families.

Jackie Robinson reflected on this activism and his belief in the advancement of the whole individual:

"I believe that a man is judged on more than the power of his hands and legs. He's judged also on the strength of his mind and his character. Not to speak out when I saw or felt an injustice would have been as bad as taking the 3rd strike, every time I came to bat."

He also embraced being that voice and coming to bat to pinch hit when necessary for those in need. In 1970, he formed the Jackie Robinson Construction Company to build low and moderate income housing for those in need of support. This was just another example of Jackie Robinson's dedication to the community. We are grateful for his legacy not only on the Diamond, but off it.

On a personal level, he was married to his wife, Rachel Robinson and had three children, Jack Jr., Sharon and David. He was known to be devoted to his family. His son Jack Jr. sadly succumbed to an untimely death at the age of 24 due to a car accident. His other children, however, continued to carry out his legacy. His daughter, Sharon, is now Vice-Chairman of the Jackie Robinson Foundation and is also a prolific author, having written on his legacy and also authoring children's books with educational messages. His second son, David Robinson moved to Tanzania and resides there with his wife and family and carries out humanitarian work to help with economic advancement. He also operates a successful international coffee company. The education and economic advancement principles

that inspired Jackie Robinson to make a difference continues to live on through his children.

It was an honor for us to award Jackie Robinson the War Memorial Award in 1964 for his humanitarian work. The New York Young Republican Club proudly continues to reflect on his legacy and encourages fostering the belief in the individual and the American Dream just as Jackie did. May his example continue to live through us today in our outreach to all communities.

Many of my patients struggle with Cancer, HIV, and other serious medical conditions. I sent my

child, who I love, upstate to live with my parents..."

"We could not obtain PPE from our suppliers, and I spent my life savings to fund my private practice to provide care for my patients..."

"When my toddler returned back to us 8 months later, I was 8 months' pregnant and getting ready for a scheduled c-section. I had preeclampsia with my first delivery and for the second pregnancy. I skipped the last few weeks of OB visits because we got infected with COVID and had to go into isolation.

Then one day, I called 911 because my husband was hallucinating from low oxygen. He was hospitalized and put on high flow nasal oxygen. I thought he would die. Soon after, I felt short of breath and experienced contractions. In that moment, I thought both my unborn baby and I would die. I was worried for my toddler. I couldn't give her to anyone else because she was also infected with COVID. Again, when I asked the City Administration for help, in the form of a home health aide with PPE, or a nanny with PPE, I was told that if I could not maintain a "safe" environment for my child, that the City would take her from me. It made me question the whole purpose of the government. Is the Government here to help? or to make things

more difficult? I realized that I would have to figure out a solution on my own. Ultimately, I roamed the perimeter of a massive hospital complex in active labor, short of breath from COVID, in the freezing cold of winter, and by myself. Miraculously, my baby was born with COVID antibodies and immunity to the deadly virus. We were immediately transferred to an isolation room that we shared, and from inside that room, I resumed telemedicine visits for my patients who still needed healthcare within hours after my C-section. I know that I am not alone with these experiences and I realize that we need a real serious change in leadership in New York City. Therefore I have decided to run for NYC Public Advocate."

There is a special opportunity in this election cycle to elect a whole new crop of qualified leaders who will return safety and security to New York City. We strongly support Dr. Devi's candidacy and know that she will lead in advocating for practical solutions to the serious problems New Yorkers face every day. Offen beat the victim into a coma with the car security device known as the "Club," while Chronis, an active NYPD officer, held the crowd back with his service revolver.

In 2008, Tierney joined the United States Attorney's Office for the Eastern District of New York. While there, he oversaw complex criminal investigations and prosecuted violations of federal criminal law, including cases involving the Colombian Norte Valle Cartel responsible for importing over 50 tons of cocaine into the United States. Tierney was also responsible for prosecuting international white-collar cases, such as a case against a call center in India utilized to contact and swindle millions of dollars from United States citizens in so-called "IRS Payment" scams.

Much of Tierney's career has been devoted to the trial and conviction of numerous members of the MS-13 street gang for the commission of murders and other violent crimes on Long Island. He drafted and applied for search and arrest warrants, presented evidence to federal grand juries, prepared and filed indictments, engaged in pretrial discovery, litigated pretrial matters by motion and pretrial hearings, and conducted jury trials and sentencing hearings, putting HUNDREDS of dangerous MS-13 members behind bars.


After the United States Attorney's Office, Tierney went to the Kings County District Attorney's Office to run their Violent Criminal Enterprises Bureau, Crime Strategies Unit, and Body-Worn Camera Unit. While in Brooklyn, Tierney oversaw all aspects of long-term violent street gang investigations and prosecutions in the office and worked with the New York Police Department and federal partners on developing investigations to seize guns, prosecute gang murders, and allocate resources to dismantle the many criminal street gangs causing most of the violence in Brooklyn.
