Club History:

1952 - The Club was among the first Republican organizations to go on record in favor of Dwight D. Eisenhower as the Republican candidate for President. Club Member John V. Lindsay helped found The National Youth For Eisenhower. Many capable Club members joined the Eisenhower administration, among them the late John Foster Dulles as Secretary of State, Herbert Brownell Jr., as Attorney General, former Board Chairman Harold H. Healy Jr. as Executive Assistant to the Attorney General of the United States, and Winthrop W. Aldrich as Ambassador to the Court of St. James's. Aldrich was later succeeded in

that role by another Club member, John Hay Whitney. In addition, many former Club Presidents achieved prominence during this period. James L. Guilmartin was appointed as United States Attorney for the Southern District of Florida, Cornelius W. Wickersham Jr. served as United States Attorney for the Eastern District of New York, and Paul W. Williams served as United States Attorney for the Southern District of New York. Paul W. Williams would be succeeded in that role by a former Chairman of the Club's Board of Governors, Samuel Hazard Gillespie Jr.

A Parental Standing to Educate

There has been much discussion in recent years about Critical Race Theory, among other socially divisive educational curriculums, that proudly present controversial issues in an emphatic way as the given truth and source of fact without providing any space for reasonable discourse. As a result, our students are left without a complete educational experience. As we continue to debate the merits of what to include and exclude in a curriculum of our educational institutions, we must not forget the parental standing in the education process and the state's active role in getting in between that relationship.

As a result of the Covid pandemic, opportunities developed for parents to spend more time with their children and appreciate first-hand what exactly their children were being exposed to in the classroom. While many teachers bravely strive to educate students and are concerned for their development and success, they can be hamstrung by a curriculum that has been forced upon them by administrators and government entities that yearn for that exclusive direct influence on our young. That influence expands not only to intellectual, but also moral development as a child is malleable at a young age and easily susceptible to positive and negative influences. The school has a role in providing resources to students and sharpening their skills, but should never replace the role of the foremost educators of our students, their parents, especially on matters concerning significant moral implications that can be subjective.

John Locke does a good job bringing to light this fundamental concept. "The well educating of their children is so much the duty and concern of parents, and the welfare and prosperity of the nation so much depends on it, that I would have everyone lay it seriously to heart..."

This point invokes deeper reflection on multiple levels, first the priority that John Locke places in the responsibility of parents for healthy development of their children. It is their "duty" first and foremost, not the state's. Second, the concept that through that very development the children will one day contribute to the "welfare and prosperity of the nation", not the children simply being products of the state and being detached from the intimate lessons that only parents can truly articulate. Now, this should not be interpreted as to dismiss the value of schools in our communities nor advocate for strictly home schooling, but rather to simply advocate for the position that the state respect the role of parents in their child's education process.

This understanding is also crystalized in our body of Constitutional law. For example, in the case, Meyer v. Nebraska, the U.S. Supreme Court held in 1923 that the Due Process Clause of the Fourteenth Amendment protects the individual's liberty interest of establishing a home and bringing up children. It was clear to emphasize that of the individual's interest, not the state's interest in bringing up children. That case concerned a state law that forbid the teaching of German in school, and the court found this encroached on the liberty interest of parents, most specifically to engage with the instructor to have him teach the class in their community.

While this nation has surely come a long way since dispute over languages in schools, the same concept remains. Controversial curriculums stemming from the state and pushed by bureaucratic entities that move out of the focus of informing, but rather an attempt at

virtue signaling do in fact interfere with the role of parents. The present situation in our nation does not truly allow for transparency and efficient parental dialogue with educators as to the focus of the learning structure. Meyer was an example of scaling back state interference with the education structure and preserving the role of parents in the process.

It is time for us to renew our understanding of this concept and begin taking steps for reform. How can reform come about?

For starters, agencies responsible for education grants and other resources for school districts must be subjected to greater transparency to and audit by the general public. There is not enough oversight and accountability or meaningful intent to engage in substantive dialogue with parents in various educational communities. This can be remedied by promoting state educational transparency legislation.

Second, the teachers' unions must be subject to greater scrutiny. At present, in many areas, they serve as the most obtrusive block towards meaningful dialogue with parents on the educational structure of their children. Whether that be in hires or school structures in a district there needs to be more transparency on what exactly is being promoted within these unions. The discourse in these unions and the philosophies they intend to focus on has a direct trickle-down effect on the students.

Third, the boards of education in various school districts. Parents should continue to demand the right to know where exactly their taxpayer money is going towards, whether that be certain education initiatives or student development. Issues of major importance such as the decision to incorporate Critical Race Theory or LGBT curriculums, how they will be implemented, and other issues such as speakers and programming all should be subject to scrutiny. The introduction of a notice-and-comment-style approach in communities would be beneficial over allowing major decisions to be made behind closed doors with parents learning of them too late to voice opposition.

Fourth, be willing to be an active participant in your child's life, have for them an alternative library, and spend intimate time explaining to them emotionally charged and controversial concepts.

Finally, on a more practical note, begin coalitions of concerned parents and approach the board of education and local schools on such ideas as potential opt-outs from controversial in-person classes when those lack factual instruction and are riven with ideological distortion. The time saved by students from taking an in-person course that has been laced with unnecessary bias can be used towards an extra study period or perhaps an educational internship for credit at a local business. These are ways to truly create options and again place parents in the forefront of educational decisions with regards to their children.

Be willing to take this stand because, if you do not, the state will, and your child will be left with a compromised educational foundation that does not allow for authentic intellectual and moral development.

Crisis at the Border

In New York City's Washington Square Park stands a statue of Giuseppe Garibaldi. While this statue may not mean a lot to you, it does mean a lot to me. And like so many Americans who have seen icons of their heritage defaced and desecrated over the past year, when the statue of Garibaldi was vandalized on June 17, 2021, I felt troubled and dismayed. Will Garibaldi, like so many great but flawed men before him, be the next to be forcibly removed by a leftist mob or government's edict?

I believe that the leftist mob's lack of knowledge on Garibaldi drove them to vandalize his statue. These leftists purport to advocate retribution and resurgence of popular interests. Garibaldi sought the same for his people. In Garibaldi's time, southern Italy lived under the thumb of the Bourbon French Regime. The French were the

He calls for property tax overhaul to correct disparities that leave multi-billion-dollar universities free-riding off small businesses and individual property owners. Under Sliwa, universities like Columbia University and New York University that have decimated their neighborhoods and abused their non-profit status will pay their fair share of taxes.

On education, Sliwa intends to retain the Specialized High School Admissions Test (SHSAT) and Gifted Talented programs, which help New York City schools provide meritbased, differentiated education to intelligent students that set them up for success in the future. He also plans to create more vocational training for students and to increase the number of charter schools, supporting a broad swathe of students by giving them tangible skills and access to teachers unbeholden to unions.

Sliwa, a voice of fiscal reason, intends to use taxpayer dollars efficiently, and he argues against other mayoral candidates' platforms of overspending on mandates that are fiscally irresponsible.

Sliwa has strong ideas for New York, and he also has classic, New Yorker chutzpah. A noted fan of electronic dance music (EDM), Sliwa embodies the work hard, play hard attitude. He is an advocate for nightlife and has roundly condemned Democrats' forced closure of New York's clubs, bars, and concerts.
