# The American Deal With a Hungarian Devil

Antisemitism is a perennial topic in American discourse, and in recent months has been of increasing concern to individuals across the political spectrum. After a spate of high-profile incidents, business leaders, NGOs, and government agencies leapt to institute programs to combat feelings of insecurity among Jewish communities. For example, Ronald Lauder, president of the World Jewish Congress, launched an “End Jew-hatred” advertising campaign; Robert Kraft’s Foundation to Counter Antisemitism launched a “Stand Up to Jewish Hate” blitz; and the White House announced an inter-agency group to counter antisemitism.

On the international front, American officials roundly condemn antisemitism in a host of allied and non-allied nations and seek to build narratives aligned with broader American policy. For example, the Biden Administration dispatched Deborah Lipstadt, a special envoy to combat antisemitism, to a range of Arab nations in an effort to combat antisemitic sentiment in advance of a Biden trip to the Middle East.

The Biden Administration takes particular pleasure in singling out Hungarian Prime Minister Viktor Orbán, casting aspersions and making explicit claims that he harbors and advances antisemitic sentiment. However, the facts simply do not exist to support this assertion and, more

concerning still, American government officials’ actions indicate a willingness to conspire with acknowledged antisemites to further a broader anti-Orbán agenda.

Orbán was subjected to withering criticism for a 2022 speech that he made in Romania, addressing a Hungarian community in Transylvania separated from its mother country in the wake of World War I by the Treaty of Trianon. Lipstadt accused Orbán of making “inexcusable” remarks and stated that she was “deeply alarmed” by his words, which she indicated had a “Nazi” sentiment. In reality, consideration of Orbán’s full remarks makes clear that they lack any antisemitic sentiment; Hungarian is a challenging language, and translations of intangible concepts inherently lend themselves to confusion. Orbán and his team have no doubt learned that lesson from this incident.

The Hungarians have learned another lesson, too: while the Americans will seek every opportunity to read translations of Orbán’s words closely—imputing, promulgating, and denouncing the most heinous concepts they can infer—Washington’s lackeys hold themselves to no similar standard. David Pressman, the United States Ambassador to Hungary, calls out Orbán and his administration multiple times per week for perceived faults. For example, he took to Twitter to issue a

disingenuous condemnation of “those who valorize Nazis [and] march in Budapest” in reference to a set of events banned by Hungarian officials. On the day cited by Pressman, only Antifa, not any far-right extremists, incited violence.

Now, with Hungary in the spotlight as it holds out on rubber-stamping Sweden’s accession to NATO, Pressman has upped the game. Pressman, in his typically self-laudatory style, posted photographs of a “fascinating” Passover Seder with a collection of “Hungarians from different perspectives, disciplines, and backgrounds.” But just who were these people, and did he really invite them for the stated purpose of “reflect[ing] on the meaning of freedom”?



Márton Gyöngyösi, president of the Hungarian political party Jobbik and a Member of the European Parliament, was one attendee at the seder. Jobbik emerged as a political force in the late 2000s by leveraging social media to deploy communications in a way never before done in Hungary. They used this network to vilify the

Roma people, introducing the term “Gypsy crime” into common discourse, and to attract a new generation of supporters.

Gyöngyösi was principally responsible for transforming Jobbik into a more acceptable mainstream party in the face of continued electoral dominance by Orbán’s party, Fidesz. However, it is clear that Pressman has chosen to overlook the disturbing statements made by Gyöngyösi in the past that American officials would have seized on to criticize Orbán if given the opportunity.

Gyöngyösi, for example, once called on the Hungarian government “to tally up people of Jewish ancestry who live here, especially in the Hungarian Parliament and the Hungarian government, who, indeed, pose a national security risk to Hungary.” Gyöngyösi has also called for an end to the existence of Israel, stating that the world has had “[e]nough of the indigenous Palestinian people being driven out of their own country by the Israeli aggressor and the Israeli terror state.”

But times change! Gyöngyösi staunchly opposes Russia in the European Parliament, while Orbán and his administration maintain a consistent call for Ukraine and Russia to achieve peace as swiftly as possible. Jobbik, under Gyöngyösi’s direction, joined last year’s failed “United for Hungary” opposition to Fidesz.

Pressman has made it clear that he has no interest in productive collaboration with Orbán. Now, he uses Passover as an opportunity to invite an anti-Orbán protagonist with a record of antisemitism, far worse than what Orbán has even been accused of, into his home. Pressman’s goals are clear, but those Americans with legitimate concerns about antisemitism ought to ask: do his efforts help or hurt the cause of defeating antisemitism? After all, everyone knows who wins in a Faustian bargain.

# New Yorkers Address the Impact of Rising Crime in NYC

The rising crime rates in New York City are causing devastating effects on families across the city. In response, the NYYRC Black and Hispanic Caucuses took action by organizing a speaker panel of real New Yorkers to discuss this issue. By bringing together a diverse range of voices, we aimed to shed light on the impact of rising crime and seek meaningful solutions for our community.

Our distinguished guest speakers included Mrs. Madeline Brame, State Director of Blexit New York; Mr. Alpheus Marcus, a candidate for NYC Council in the 9th District; Mr. Sam Adolfo, AF-NE Hub Coordinator; Mr. Jude Somefun, Chairman of NYYRC Black Caucus, and Mr. Argilio Rodriguez, Chairman of NYYRC Hispanic Caucus. The event was sponsored and hosted by Mr. Larry Gillheeney of America's Future.

The goal was to hear from the people rather than solely relying on elected officials. Through this effort, we hope to make progress in addressing the problem of rising crime and support families in New York City. In order to provide you with a concise overview of the Q&A session, we have summarized the responses during the speaker panel, with the exception of the first question, for your convenience and benefit.

## What is the state of crime in NYC?

**Argilio Rodriguez:** Since the implementation of cashless bail in New York in 2020, crime rates, particularly for petty and grand larceny, have soared. Contributing factors include a lack of state interest in addressing cashless bail, "woke"

judges and district attorneys who refuse to exercise discretion, and the Defund the Police movement, making it difficult to envision positive change in the near future.

**Madeline Brame:** The state of crime in New York City, as witnessed by a grieving parent seeking justice for her son's murder, is deeply concerning. Despite numerous encounters with the legal system, Mrs. Brame has observed multiple instances of individuals with open warrants being released, reflecting a troubling trend of leniency and a seemingly out-of-control crime, ranging from murder to petty theft.

**Sam Adolfo:** Observing the media coverage and hearing feedback from people on the ground, it is clear that rising crime rates in New York City are a serious concern. NYPD officers report emboldened criminals, and there is a need for effective solutions to address the issue, including changes to cashless bail policies and a reduction in leniency for criminals.

**Jude Somefun:** Crime in New York City has significantly impacted the state, as evidenced by the decline of small businesses and the rise in petty larceny and violent crimes. In addition, the lack of enforcement for more minor offenses emboldens criminals, while societal moral breakdown and disregard for community investment contribute to an increasingly worsening crime situation.

**Alpheus Marcus:** The state of crime in New York City is also influenced by some large chain stores and corporations that choose not to prosecute those arrested for crimes against them, potentially due to financial benefits such as tax write-offs. This lack of prosecution exacerbates the crime situation and places the burden back on society, highlighting the need for greater diligence and pressure on corporations to take responsibility.

## Are police officers allowed to do their jobs?

Certain policies, such as defunding the police and insufficient patrolling, prevent police officers

from effectively carrying out their duties. The negative media coverage and hostile environment often lead officers to back off, allowing crime to flourish. Some NYPD officers have considered quitting due to the increased risks and lack of respect. The vilification of the NYPD and the high attrition rate make policing a frustrating profession in the city. Furthermore, officers feel hamstrung by district attorneys and judges, making it difficult to do their jobs effectively. Finally, politicians and activists like Al Sharpton have capitalized on racial tensions and community emotions rather than working to build better relationships between the police and the communities they serve.

**Are people naturally bad, or are they a product of their environment, leaving them to commit crimes? What is to blame?**

People are not inherently bad, and one's upbringing and environment significantly influence their behavior. A child's development and the company they keep in school can influence whether or not they engage in criminal activities. Parents must make informed decisions about their child's education and environment to ensure their positive growth. The breakdown of the nuclear family and the absence of consequences for misconduct contributed to the rise in crime. A strong sense of morality, often rooted in religion, can help guide individuals toward making better choices. Encouraging intact family units with both parents present is crucial in raising responsible and respectful children.

**Is carrying a firearm a good way to stay safe?**

A firearm can deter potential threats, similar to why people might carry pepper spray for self-defense. However, a gun is only effective when used by someone with the proper intent and training. In some cases, even well-trained individuals may choose not to use their firearms in a conflict situation. While the Second Amendment protects the right to bear arms, it is crucial that gun owners are responsible and trained in using their firearms. In places like New York, self-defense laws may be under attack, but it is vital to preserving individuals' rights to protect themselves. Ultimately, the right to self-defense is a natural right, and firearms can serve as a

powerful deterrent against crime when used.

**Is there any illegal behavior here that should be legal from a crime prevention perspective?**

Two main aspects should be legal from a crime prevention perspective. First, the right to own and bear firearms in places like New York City, where laws make it increasingly difficult despite previous court rulings. Reintroducing such laws challenges the Supreme Court to strike them down again, suggesting that owning a firearm should be legal in specific situations. Second, the right to self-defense should be protected, considering cases where individuals legally defend themselves with a gun but are later prosecuted for its use. If people are penalized for exercising their inherent rights, it is hard to consider them truly legal. Ensuring everyone has the opportunity to be trained in firearm use and defense can create a deterrent for criminals and promote respect among community members, aligning with the original intentions of the Second Amendment.

**Do you think the future of the world is safer or more dangerous?**

In summary, the future safety of New York City is uncertain, but analyzing trends may provide some insight. People who lived through the 1980s recall feeling hopeless but acknowledge that life moves in cycles. Recently, there has been a shift in political affiliations, with black and Hispanic voters increasingly leaning Republican due to concerns about crime and law enforcement. This trend may continue until a balance of power is restored. In addition, while crime rates have decreased over the past 30 years, the focus on crime distracts from other pressing issues, such as high taxes and the cost of living. Ultimately, common sense and political awareness are needed for the city to address these challenges and create a safer, more prosperous environment.

**What does the future of New York City look like?**

Despite current challenges, there is optimism about the future as we come together to address these issues and effect change. By staying focused and working collectively, we can create a brighter future for everyone, even in the face of adversity.

### Today's Conservatism Exists on the Outside

It's just another day when the media characterizes Republicans as scheming, pouncing, or committing some deplorable action. Likewise, it's just another day when Republicans are described in a detached manner, as an outside group that can be studied and analyzed, but is separate from enlightened society. One can notice these things, complain about them, criticize the prevailing narrative, and add context, but one should also not be surprised to read about conservatives this way daily.

I'm thinking about this as I read another think-piece that casts Ron DeSantis as an authoritarian. Authored by Helen Lewis, *HOW DID AMERICA'S WEIRDEST, MOST FREEDOM-OBSSESSED STATE FALL FOR AN AUTHORITARIAN GOVERNOR*, critiques recent actions by DeSantis, including his reaction to a drag show involving minors, and his attempt at removing Disney's special status from its Disney World property in the state.

Lewis' critique uses two devices; she makes an argument and she paints a picture. The argument is that DeSantis's actions are power-mad, and that they're opposed to conservatives' alleged love of liberty and freedom of expression. The picture is of a duality in popular Floridian culture and politics: on one side there is the stereotypical reckless and unashamed "Florida man," and on the other side there is the totalitarian, corrupt political mastermind.

The argument is not new. The idea of there being this kind of contradiction has been alleged against conservatives since time immemorial. It was made when security was heightened after the September 11 attacks.

It's an easy argument to make against conservative actions. How can you take any action to effect change if your core messaging is based on conservative ideals and limited government? In the real world these decisions are made against political pressures and constraints.

Lewis' argument acknowledges but does not recognize the importance of a key detail: Disney is a special status entity on its property in Florida. The importance of this is completely underemphasized. This means that the company has privileges not afforded to other private groups in the state. Why shouldn't the values promoted by the company be in-line with those of Floridian voters? If they're not, why shouldn't its special status be at risk?

It's not an issue that Lewis' argument is not new—political arguments don't need to be original if they're fairly deployed. But I suspect Lewis's arguments don't get the same kind of scrutiny that they would if they were less in-line with what is normal in her industry. That's why I'm more interested in the second feature of the article: the way it builds a narrative around the personas involved.

"Florida Man" is a meme that's become popular over the last ten years. News stories are cited that describe this character doing crazy, illogical, or dangerous stunts with some degree of hilarity. These stories are more common in Florida than in other states because freedom of information laws make it easier for journalists to obtain police records and other documents.

Nevertheless, the phenomenon gives Florida an association with this kind of randomly hilarious behavior.



DeSantis is not a "Florida Man," according to Lewis. He's too posh. He's Ivy-League, calculated, and possibly corrupt. It's unclear whether Lewis thinks DeSantis is trying to come off as this character, yet the comparison is stressed.

On its surface, Lewis' description of Florida and its residents' antics is quirky and charming, but there's an important implication. The "Florida Man" phenomenon is, for the purposes of this piece, pathological. This is never an accusation made directly about any specific person. It is, however, a way of creating an image of conservative constituents as being apart from the enlightened class. The Floridians who put DeSantis in power are a quaint, kooky group that can be analyzed from afar.

I see this as the "othering" of conservative voices and ideas. It's a key feature of how Western media and intelligentsia treat conservatives. Conservatism is completely distinct from what is right and proper in the enlightened world.

The recent "Republicans Pounce" phenomenon is a transparent example of how the media tends to see itself as separate from Conservatives, but fails to use the same distinction with respect to Liberals. Whenever there is a criticism to be made of Republicans, the underlying issue is the basis for the story. When there is a criticism of Democrats, on the other hand, the story is about Republicans seizing the political moment.

My observation of political othering is not itself a new idea, and it can be encapsulated in the old criticism by the right of the "liberal media." What is new, I suspect, is the extent of the distance between normal voters themselves and the enlightened media and intelligentsia.

Never in my lifetime have the values of elites felt so different from those of the general public. Yet the public is inundated with news, movies, HR initiatives, and educational fads that push these values down their throats. What's interesting to me, and what I think Republicans should study as we head into 2024, is the degree to which this political capture of the most important

institutions in our lives is effective for the left politically--and to what degree it's alienating to normal voters.

Republicans are inarguably more in tune with the average American when it comes to cultural issues. Some of the most important issues in the political conversation today deal with the dismantling of basic concepts that form the foundation of Western culture.

At the heart of the article was a criticism of DeSantis's attempt to remove Disney's special status over the property on which Disney World is built. DeSantis made this move as part of a feud in which Disney CEO Bob Chapek spoke out against Florida's Parental Rights In Education bill, which was misleadingly nicknamed the "Don't Say Gay" bill by journalists. The most controversial section of the bill prohibits discussion of sexual orientation or gender identity in classrooms with grades kindergarten through third.

It's a provision that's so modest, it's hard to see how it was newsworthy at all. But it's completely counter to the left's vision, which is dominated by the deconstruction of social norms.

There is an opportunity for Republicans in the growing cultural rift. Republicans should lean into normalcy. They should do so through their own channels, and to the extent that they can, they should strategically use the traditional channels to get their message across as succinctly and clearly as possible. But their message needs to connect to what normal voters feel intuitively. Those feelings are likely being quashed at work and school, and even in church, and those voters probably feel completely unrepresented by the media.

If Republicans can demonstrate themselves as being above the anointed vision, they will reach these people. In doing so they will demonstrate the usefulness of conservatism as a system of values. More importantly, they will put themselves in a position to deliver the kind of help that many feel like our culture needs.

I'm proud that our Board was unanimous in its steadfast decision to continue our unbroken, century-long streak of hosting its Annual Gala despite ridiculous restrictions placed by frauds like Cuomo. ### Pardon Sgt. Daniel Perry

The New York Young Republican Club calls on Texas Governor Greg Abbott to pardon Sgt. Daniel Perry, whom a Soros-back prosecutor charged with and whom a skewed and leftist jury convicted of murder on Friday.

Sgt. Perry was driving an Uber when a crowd of protestors surrounded it; over twenty sets of fingerprints were lifted from his car on all sides. In that melee, one protestor, Garrett Foster, lifted an AK-47 towards Sgt. Perry. Sgt. Perry, fearing for his life, took appropriate measure to neutralize this threat.

Our Club has tremendous respect for First Amendment rights, and we unequivocally endorse Americans' rights to keep and bear arms and to defend themselves when threatened. Protesting in a road is not smart. Protesting in a road while carrying a rifle is stupid. Protesting in a road while carrying a rifle and raising that rifle towards a driver whom the crowd of which one is a part has surrounded is the height of stupidity.

In the so-called 2020 "Summer of Love," our nation was riven with "Black Lives Matter" protests which destroyed property and resulted in numerous deaths, including instances which our Club previously condemned. Authorities, particularly those in Democrat-controlled cities,

opted not to provide security to their residents. Their abrogation of responsibility placed heightened need on individuals to defend themselves. Such was the case with Sgt. Perry.

The aforementioned facts were recognized by the authorities; however, despite a consensus that Sgt. Perry need not be charged with a crime, Soros-backed Travis County District Attorney nonetheless pursued a murder charge. The leftist population of Austin, Texas does not lend itself to making objective and fact-based decisions on critical issues such as shootings. Inevitably, such a jury is stocked with "Black Lives Matter" boosters chomping at the bit to crack down on someone who, as the prosecutor made clear, harbored no sympathies to that organization.

Tennessee uses this delegated authority to, in Article II Section 12 of its constitution that "each House may determine the rules of its

proceedings, punish its members for disorderly behavior, and, with the concurrence of two-thirds, expel a member."

Ra is an attorney (albeit not one licensed to practice in Tennessee); therefore, one must conclude that he either lied in his tweet to seek clout or that his mental prowess is akin to that of a slug.

Ra also accuses a supermajority of members of the Tennessee House of Representatives of acting in "a disgraceful way." This mentality bespeaks Ra's low interest in winning. When faced with a problem, he has no interest in solving it; he is a pathetic man who would let anyone walk all over him, even when granted explicit authority to solve the problem.

Does Ra apply this mentality in other aspects of his life? Do his constituents know that their representation is so weak?

The New York Young Republican Club asserts that the people of AD-19 deserve better representation than Ra could possibly provide.
